## JSC Soccer Training Academy Season 2021 – 2022

### **General Rules & Guidelines**

Admission is open to all boys of age 5 – 16 years based on selection trials conducted by JSC as per rules and regulation of the club.

#### **Training Days and Time :**

Friday morning : 6.00 am – 9.00 am

Saturday evening : 9.00 pm – 11 pm

(Note timings and venue are subject to change as per ground availability and operational requirements)

JSC may hold additional training sessions during public holidays or other days.

Trainees must obtain full consent of their parents before joining JSC. The Academy will not accept any ward without the consent of their parents.

Trainees must obey and respect JSC coaches, officials and seniors at all times. Also, treat fellow players with respect and sportsman spirit at all time. Encourage, cooperate and support teammates at all times.

School curricular or co-curricular activities should not be affected due to football training. Top priority should be given to studies. As an encouragement for studies, JSC will honor trainees who obtain meritorious grades in the school annual exams or co-curricular events.

Trainees have to take care of their health and must know that injuries are part and parcel of sports, and may happen during training at JSC Academy too. In case of an unfortunate incident/injury, JSC officials or co-players must not be held responsible or liable.

Trainees have to bring their own football, socks, shin guards (mandatory) and the jersey provided by JSC and come in proper boots.

All trainees must come to the ground with full kit and sufficient water, at least 10 minutes before the practice sessions and ensure their attendance is recorded.

Irregular attendance, unexpected absence, habitual late coming, objectionable behavior on the ground/camp, can lead to disciplinary action against the trainee.

Late attendance without valid reasons and acceptance of the coaches will be recorded as absent and may result in disciplinary action.

Trainees are not allowed to leave the camp before completion of the training session.

All trainees must fully abide by the rules of the academy, rules of the ground Owner/Management and above all the laws prevailing in KSA.

All trainees must attend seminars, theory classes, field trips etc., as and when organized by the Academy. Parents too have to attend any of these sessions if requested by the Academy.

If a trainee wishes to leave the academy, he should notify in writing, one month in advance.

**Fee Structure:**

- Non-refundable registration fee SAR 500/- to be paid initially upon confirmation of a trainee's selection with 3 months fees in advance.
- Annual Fee is 1500 SAR for a period of 10 months; Current Fee structure is designed for 2 sessions a week.
- Fees have to be paid in the first week of each quarter.
- Fees paid are non-refundable and if a trainee is not available or absent for a month or goes on vacation there will not be any reduction in fees for that period
- JSC may decide to increase the fees if required but with prior notice to parents. Fees could also be increased if there is any increase in number of training sessions per week.

JSC coaches' are solely responsible to select a team for matches based on trainee performance and team structure. Trainees or parents shall not question the coaches' decision.

**Facilities provide by JSC:**

- Specialist Coaches for particular age category & Goal Keeping.
- Health & Fitness seminars and sessions for trainees & parents.
- Complete Training Kit.
- Training & Friendly Matches .

**JSC Events:**

JSC will choose best trainee of the month based on their overall performance including discipline on and off ground and school activities.

Annual Day, In House Tournament, Camp Fire and Fun Day to be held.

**Documents Required:**

A selected trainee has to provide 2 photographs, copy of iqama, Copy of Passport and valid insurance card along – with registration form duly filled and fees to complete the admission procedure.

**Transportation:**

Parents must arrange transportation and ensure their wards reach the camp on time and picked up on time. JSC will not be responsible for the child being left behind after the stipulated training session time.
